The GSCA offers to qualified members a Breeder Listing, which will be maintained on the Club's Website.

The Breeder Listing service is available to GSCA members who maintain active membership status, have been members for a minimum of four (4) consecutive years, and have completed the attached BREEDERS LISTING APPLICATION & QUESTIONNAIRE. Completed applications and questionnaires must be submitted to the GSCA Secretary for review and consideration by the GSCA Officers and Board of Directors. The GSCA reserves the right to refuse an application and/or remove a listing at any time without explanation. Cost for listing is \$35.00, payable to the GSCA, and due with submittal of a completed Breeder Listing Application and New Applicant Questionnaire.

The GSCA Board of Directors will review any inquiries and/or complaints received. The breeder will be promptly notified and will be expected to address the complaint and resolve the issue in a timely manner, within 30 days. Failure to address and resolve complaints could lead to removal of a listing by the GSCA Board of Directors.

A breeder will immediately be removed from the list if their GSCA membership is lapsed for non-payment of dues (membership reapplication required), suspended through club action, suspended from AKC privileges, and/or convicted of animal cruelty.

The Listing service is available only to the owner of the bitch and the litter(s) must be whelped and raised on the premises of the bitch owner. It is expected that all sales, contracts and agreements are the responsibility of the bitch owner that handles the whelping, raising, and selling of pups. If the bitch is co-owned by a non-GSCA member, the co-owner can apply for club membership and when the 4-year membership-qualifying period is fulfilled, they can then apply for the breeder referral service.

BREEDER LISTING GOALS AND GUIDELINES

A. Communication

No individual member has the authority to bind the GSCA in any way unless same is done in writing and approved by the Board of Directors the GSCA.

B. Breeding

The GSCA has done no independent verification of any of the information provided for and used in individual classified ads placed in GSCA publications or elsewhere. Whereas the GSCA does require that ads placed in GSCA publications include the CHIC certification on both the sire and the dam we make no representations whatsoever as to the accuracy of this information and we have not independently verified this information.

Breeders have a responsibility to know as much as they are able to about the genetic makeup regarding the lineage (a minimum of 3 generations prior) of their breeding stock. Suitable breeding partners should be selected carefully, taking into account inheritable defects of previous generations.

C. Placement

No breeder should knowingly sell a Giant Schnauzer to a dog broker, pet store or wholesale dealer. Members should inform and instruct each new or prospective owner of the responsibility and proper care, training and socialization of a puppy or adult Giant. It is the seller's obligation to discuss the unique temperament, guard instinct, character and activity level of the Giant Schnauzer breed, recognizing and explaining that the strong characteristics of the breed may not be suitable for many households and inexperienced dog owners. All new owners should be provided with the following:

- Feeding instructions and dog food recommendations
- Medical records including vaccination dates and vaccines used
- Parasite exams and treatments
- Veterinary health certificate
- Pedigree with a minimum of 3 generations
- AKC registration papers specifying full or limited registration
- All puppies will be micro-chipped and registered in a National Data base
- Written guarantee or contract that specifies and explains registration details including expected receipt date, names of owners, official name to be on the AKC registration paper and any other details specific to the individual transaction between the involved parties.

Show prospects require a more detailed agreement that includes expectations and responsibilities of the parties, provides directives regarding replacement, and other policies. These should be addressed in writing with a detailed contract to protect the interests of both parties.
